### AUTHORIZATION AND AGREEMENT

Applicant authorizes InterState Propane (Hereinafter "Seller") or its assignee to make whatever inquiries it deems necessary in connection with this open account application and in the course of review or collection of any credit extended in reliance on this application. Applicant authorizes Seller to check their individual credit history in connection with a business transaction involving the firm making the application. Applicant further authorizes any person or consumer reporting agency to complete and furnish to Seller or its assignee any information that it may have or obtain in response to such inquiries and agrees that such information, along with this application, shall remain Seller's property, whether or not credit is extended. Applicant further warrants and represents to Seller that Applicant is doing business and is solvent. Applicant agrees to notify Seller immediately if it becomes insolvent or otherwise unable to meet current obligations when due. Venue for purposes of the enforcement of any obligations incurred as aforesaid shall be in Sacramento, California or Yolo County, California. This agreement shall not be effective until accepted by an authorized representative of Seller at its offices located at 8221 Alpine Avenue, Sacramento, California 95826. Facsimile signatures of applicant shall have the same force and effect as original signature.

**Payment Terms, Net 10 days—due and payable in full 10 days from date of delivery and/or service.** Failure to pay the full account balance within 10 days from day of delivery and/or service shall result in a default and the assessment of a late charge and/or statement fee. The Applicant agrees to pay all invoices plus applicable taxes at the time of delivery or service work. The Seller shall have no obligation to supply any propane, tanks, equipment or services to the applicant who is in arrears in the payment of any invoice or who is in default of any obligations to the Seller.

**Taxes:** The applicant agrees to pay all personal property taxes and other taxes, assessments or similar charges that may be levied on any tanks or equipment while in the possession of the applicant.

**Use of Tank:** To promote safety and to comply with regulatory codes, the applicant will not allow anyone other than the Seller to supply propane into any tank owned by the Seller which is leased or loaned to the applicant. The applicant agrees that they will not move, loan, lease, sublease, rent or dispose of the tank or other equipment or assign this contract without first obtaining the written consent of the Seller. The applicant further agrees to notify the Seller at least thirty (30) days before any sales or change of ownership of the premises on which the tank or other equipment is installed. These terms will be subject to the individual laws of the state from which they were entered into and those laws will supersede any provisions of these terms that may run counter to those statutes. Title to the propane shall pass to the applicant at the time the propane is delivered. Warning: Chemicals known to the State of California to cause cancer, birth defects, or other reproductive harm are created by the combustion of propane.

The undersigned agrees to the following terms in all credit transactions with InterState Propane unless otherwise agreed to in writing by authorized company officers or owners. A service charge equal to one and one half percent (1 1/2%) per month will be charged against all past due amounts with a minimum of \$.50. A service charge of twenty-five dollars (\$25.00) will be charged against all returned checks. Applicant agrees to pay all attorney's fees or collection charges associated with the collection of its past due account. A collection charge of one third (1/3) of the outstanding balance owing will be added. There will be a Fuel Surcharge Fee charged on each invoice to offset the cost of compliance with various state and federal regulatory agencies. To assure an adequate supply of L.P. Gas, the applicant will allow and be responsible for deliveries of L.P. Gas without signature at the time of delivery. The applicant also acknowledge that service may be disconnected if payment is not made in accordance with your terms. This authorization and request for delivery remains in effect until revoked by either party in writing.
